RECOMMENDATIONS

- 3. Do not add any material different to the catalyst recommended for these products.
- 4. Do not use these products if the molds used to make the final parts are made of silicone; this because they can present problems of stickiness on the main face.
- 5. Do not mix organic peroxides with metallic soaps, amines or any type of accelerators or promoters, because it can result in a violent decomposition with fire or explosion.

Uncatalyzed PCP-9407-05 / PCP-9407-07 resins, have a usage life of three months from invoice date, when stored at 25°C or below, in a closed, opaque, factory sealed container, out of direct sunlight, heat sources or moisture. For every 7°C increase in storage temperature, the shelf life is reduced by one half.
