- 4.- Do not mix organic peroxides with metallic soaps, amines or any type of accelerators or promoters, because it can result on violent decomposition with fire or explosion.

# **STORAGE**

Uncatalyzed PRA-6620, PRA-6630, PRA-6631, PRA-6632 and PRA-6634 resins, have a usage life of three months from invoice date, when stored at 25°C or below, in a closed, factory sealed opaque containers, and out of direct sunlight, heat sources or moisture. For every 7°C increase in storage temperature, the shelf life is reduced by one half.
